Dear Supporter,

This summary is intended to serve as an accompaniment to our FY19 Form-990 to help guide your review our tax filing.

In 2018, the World Food Program USA changed its fiscal year-end from December 31 to September 30. As a result, the organization filed a short year return for the previous year covering the nine months from January 1, 2018, to September 30, 2018. The current year activity presented in this Form 990 covers twelve months while the prior year activity covers nine months, making it difficult to compare financial information across the two periods.

Similarly, the reportable compensation of Officers, Directors, Trustees, Key Employees, Highest Compensated Employees, and Independent Contractors reflects compensation paid during the calendar year in 2018 as reported on the 2018 Form W2. This creates a timing difference between the calendar year compensation information and the fiscal year financial results presented in Form 990.
